A. Updates: Hiring and School Opening

Mrs. Moriarty reported that there is currently one Social Studies Teacher position open; we anticipate filling that position by the end of the week.

Mr. Cunningham moved, seconded by Mr. Billings, to authorize the Superintendent to continue with the hiring of personnel until all positions are filled. The motion passed 4-0.

At this time, First Student is five Bus Drivers short for Inter-Lakes. There are drivers in the process of obtaining licensure that should fill these vacancies. Progress is being made filling Paraeducator positions, we have received several applications. Several Substitute

Teacher applications have been received also; a great deal of work has been done to support Substitutes to make their work a more positive experience.

A. Strategic Planning

Mrs. Moriarty noted that the current Strategic Plan was developed ten years ago. Efforts have been made to keep the District Mission and Core Values as visible as possible; on the website and within the schools.

Discussion ensued regarding volunteers in the schools and how the District works to make volunteering a positive experience. Exploring ways to tap into the opportunities within Inter-Lakes would be beneficial; time coordinating and supervising volunteers was further discussed.

B. Members of the Administration

Mrs. Temperino reported that the School Bus Grant application was submitted last week. The grant was written for 5 electric buses (just under \$2 million); we do not know whether any portion of the grant will be funded.

Mrs. Temperino indicated that the second RFP for 14-passenger buses had gone out, there was no interest from local or larger corporations to submit a proposal. We are now looking at alternatives to move forward.

Discussion ensued regarding plans for Outdoor Classrooms.
